En caso de no existir oposición o de no ser notificado en la forma antes indicada se procederá con el tramite respectivo conforme lo establece la Ordenanza que regula el plan masivo de adjudicación, escrituración y venta de terrenos mostrencos, fajas y lotes ubicados en la zona urbana, zonas de expansión urbana, cabeceras parroquiales y centros poblados del cantón Tosagua.
